

Market Commentary / Recent Trades

Iron ore futures fell Wednesday amid concern over the economic growth outlook due to a resurgence in Covid-19. Shanghai recorded an increase in new virus cases on Tuesday.

Restrictions have been eased in some areas, but much of the city remains under strict lockdown. There have also been restrictions in other parts of China, dampening economic activity and steel demand. Prices were jumpy throughout the Sing morning having opened at \$151.35 and rallying to \$154.45 before Singapore Midday. throughout the session Jun/Jul traded -\$0.05 in some clips of 50kt-100kt , Apr/May found liquidity and May outright saw most of the attention on outrights.

由于新型冠状病毒疫情的影响和对经济增长前景的担忧,铁矿石期货价格今日下跌。周二,上海新增病例有所增加。一些地区的限制已经放松,但该市大部分地区仍处于严格的封锁状态。中国其他地区也出台了限制措施,抑制了经济活动和钢铁需求。整个新加坡早间价格都在剧烈波动,开盘时报151.35美元,在新加坡午盘前反弹至154.45美元。6月和7月价差于负0.05美元交易5万吨至10万吨,4月和5月有一些流动性,5月主要集中在空头上。
