







Some very sizeable volumes in the T+1 with strong axed selling on Jun which saw trading in clips as large as 80kt throughout the session. Spread interest was also mainly centred on the front end of the curve, as prices again retreated to close \$125.75. Jun/Jul saw considerable interest having been paid at 0.90, going on to trade as wide as 1.10.
