Market Commentary / Recent Trades

Iron ore saw a recovery in prices over both the Singapore and London morning amid some sized spread interest. Spreads were volatile with Jul/Aug trading in size clips in the Singapore morning at \$0.45 originally and then \$0.35. By midday London however, this had widened to \$0.70.
