With the news coming out of the EU regarding natural gas we saw the price of natural gas rocket up. With this we saw the INTL market firm up and more bids entered the market. We saw bids across the AG Urea contract, but it was a struggle to find a seller in the market that was being bid up. This seemed to slow down as the day went on and bids eased.
