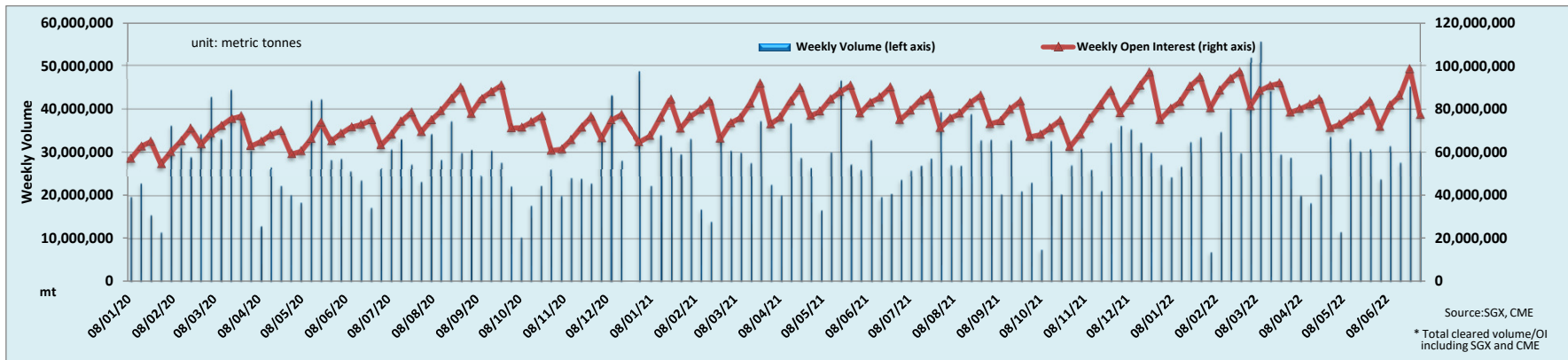
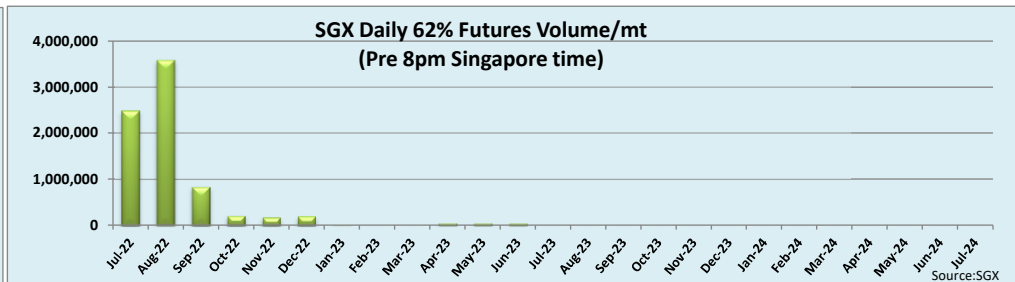
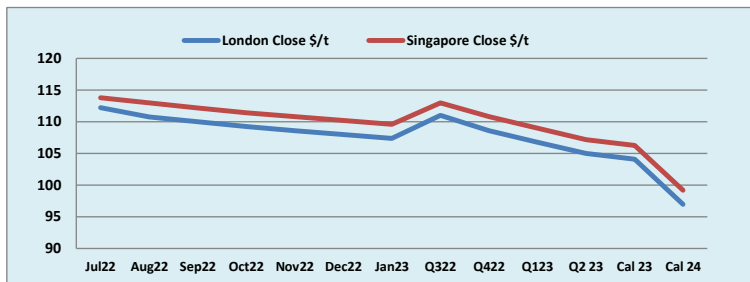
A rather slow end to the week, only tenor trading with any significance was JUL/AUG, aside from that liquidity was limited and largely in small outright clips.
