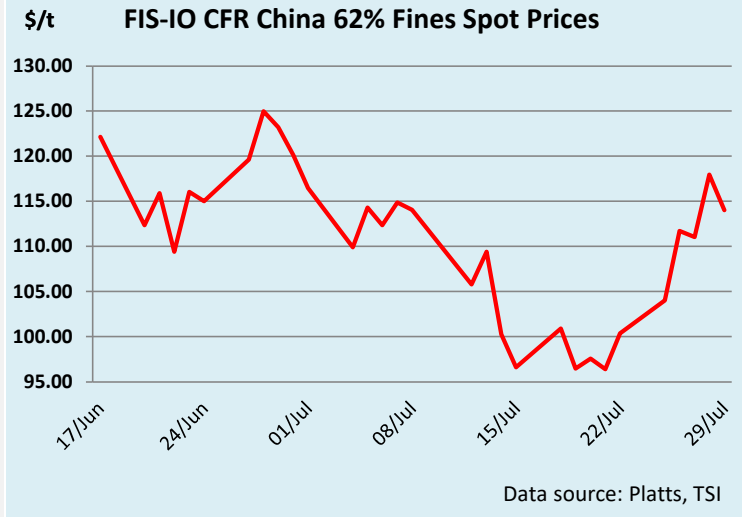

## Market Commentary / Recent Trades

Iron ore markets came off across the morning off the back of underwhelming news out of China the day before. Thursday's Politburo meeting spoke of a broader directive to "stabilise the housing market," but did not specifically mention more supportive measures. There was some size trading on Sep seen in the Singapore morning in clips of 100kt+, though much of the activity from then on was on front outrights in small sizes, with slightly more on the offer side.

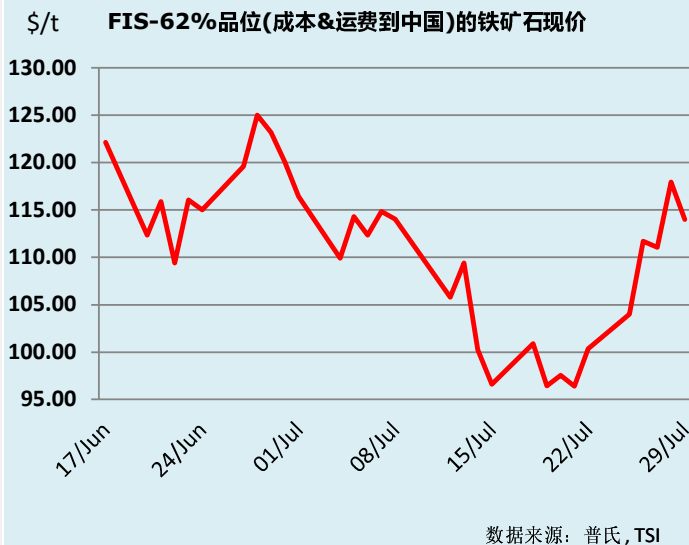
