Market Commentary / Recent Trades

Iron ore fell a touch today on thin volume following the negative iron ore port inventory data. Despite that, some investors were still optimistic on steel demand in September, as more steel mills gradually resumed operations to lift output before the peak demand season. According to a Mysteel survey of over 247 Chinese steel mills, blast furnace operation rates were up 3.54% w-o-w to 76.2%. Capacity utilisation rates also improved for a second week, edging up 1.6% w-o-w to 81.2% over 5 – 11 Aug. Iron ore inventories at 45 major Chinese ports continued to build up to a total of 138.9 million tonnes, up 1.3% or 1.8 million tonnes, and near a three-month high.

市场评论 / 近期交易

受港口铁矿石库存数据下滑影响,铁矿石今日成交清淡,价格小幅下跌。尽管如此,一些投资者仍对9月份的钢铁需求持乐观态度,因为更多的钢厂逐渐恢复生产,以在需求高峰季节之前提高产量。据我的钢铁网对中国247多家钢厂的调查显示,高炉开工率同比增长3.54%,至76.2%。8月5日至11日期间,产能利用率连续第二周上升1.6%,至81.2%。中国45个主要港口的铁矿石库存继续增加,总计达到1.389亿吨,增长1.3%10.00,即180万吨,接近三个月高点。
