
### **Oil and Energy Market News**


Brent crude oil front month futures ended the day up, printing \$94 at 1615BST. Highs in the day reached \$95.32 and lows touched \$92.65.

G7 have agreed to implement a price cap on Russian oil and oil products. The strategy comes as a bid to hit the Kremlin's war fund and also to attempt to reduce the global high energy prices. Russia announced prior that they will not supply any oil at all to nations that adhere to the price cap.Iranian nuclear deal is said to be "moving backwards" after the White House stated that Tehran's response had not been constructive at all.


