
### Oil and Energy Market News


Crude prices continue to plummet this morning on the back of poor demand outlook as worldwide interest rates climb to near record levels thus amplifying the expectations of a global recession. Brent crude front month futures are already down almost \$1.50/bbl from Friday's settlement.

The Iraqi region of Kurdistan exported over 37 million barrels of crude oil over the three months to June this year, raking in \$3.8 billion worth of sales. The region has been exporting oil independently of the central Iraqi government.


