Oil and Energy Market News


Brent crude oil prices have fallen more than 1% in this morning's trading, pressured by a strengthening dollar and builds of crude storages. These are offsetting the price support that might come from the oil majors shutting off production in the Gulf of Mexico in preparation for Hurricane lan.


Goldman Sachs has cut its io price forecast in light of the deteriorating economic outlook. The investment bank said that it remains bullish on the commodity given the state of the "critically tight" market however they reduced their predicted average price of oil for Q422 from \$125/bbl to \$100/bbl.


