Traders will continue to look at possible escalation in the Ukrainian Russian war, along with fear of economic instability world wide. **INTL**: A quiet end to the week in the INTL market with little interest across the contracts. Egypt Oct traded here at \$715 and there was selling interest around higher levels on the follow, but bids were thin. We continued to see AG and Brazil bidding interest but offers were higher levels than bids were willing to pay.
