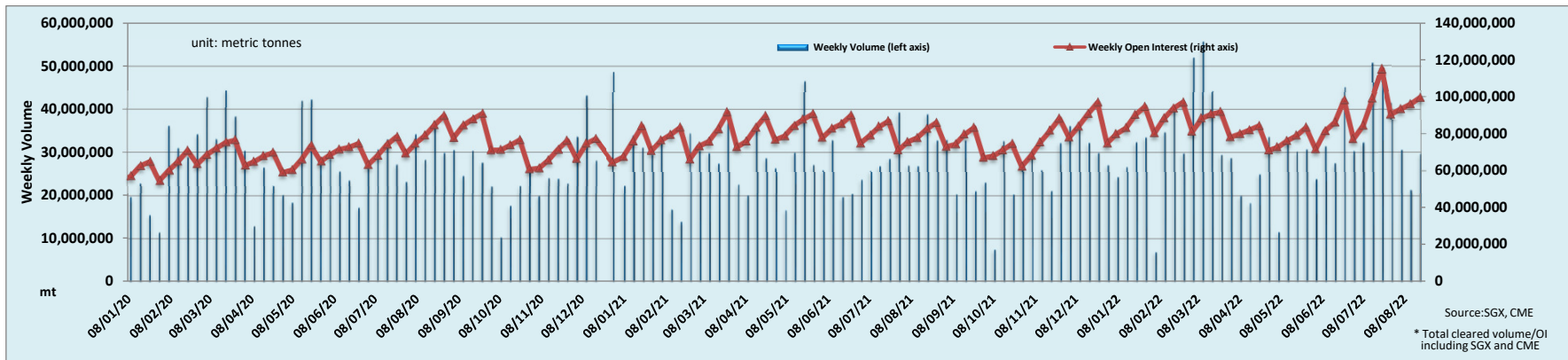
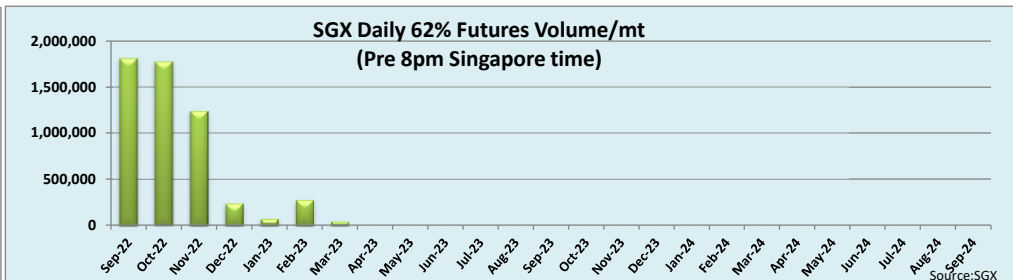
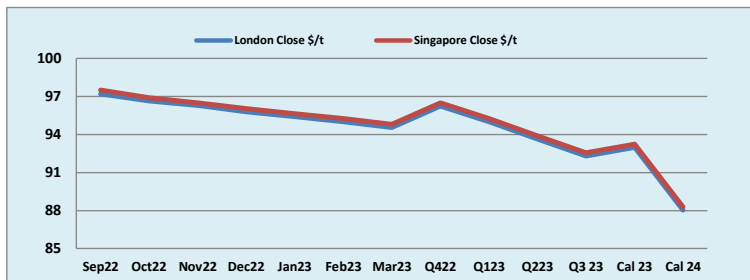
SEP/OCT Continued to find consistent liquidity at 0.55 throughout the afternoon, just as it did in the morning. Liquidity down the curve picked up slightly as NOV/Q1 traded 1.30 in 150k/50kt and Q1/Q4 traded 4.30 in 5kt/m. OCT/NOV finally traded at 0.35 having been bid there all afternoon yesterday in clips of 20's and 30's.
