


## 20 September 2022

Prices came off in the T+1 retreating to lows of \$94.60 before recovering slightly into the close. Selling interest was heavy from the offset, carrying on from the morning, particularly on the spreads. OCT/NOV traded in decent size several times at \$0.65 before retreating \$0.05 to trade in smalls.
