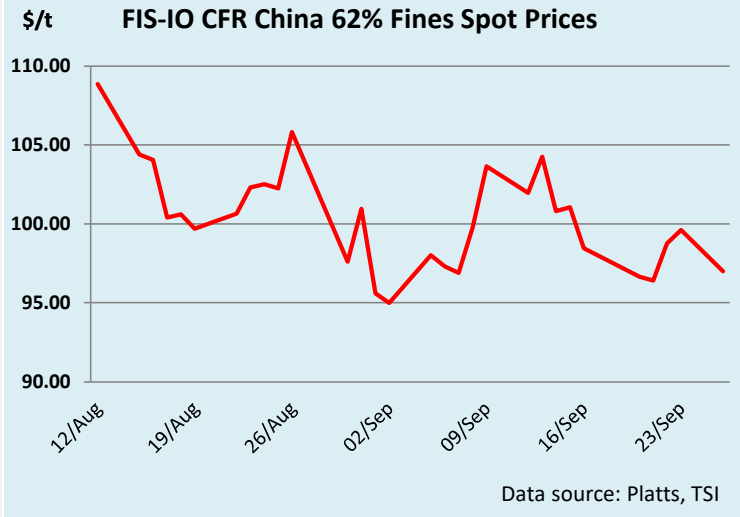

Market Commentary / Recent Trades

Equity markets continued to tumble with most metal prices also heading lower in the face of a rallying dollar and recession concerns. Inevitably, iron ore futures followed suit and traded down to near \$95 on Monday. In terms of iron ore demand, sales in both seaborne and portside markets remained firm, despite the volatile prices.

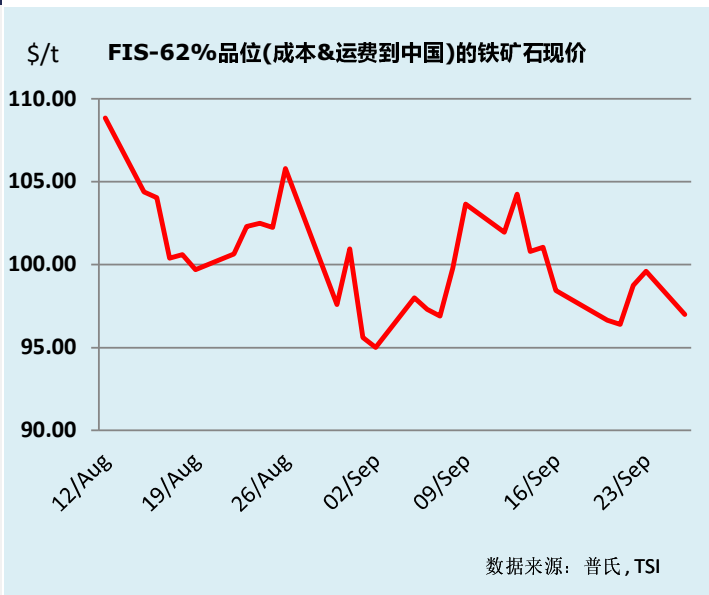
