


Whilst Brent crude futures fluctuated between a \$2.40 intraday range over the session, the front month contract is trading around \$92.10/bbl, 50 cents over yesterday's settlement.

BP are undergoing the acquisition of biogas producer Archaea Energy for \$4.1 billion. The move is the largest renewable natural gas takeover ever – showing that there is some effort by the oil and gas giants to transfer to greener focuses.

3.5% Rotterdam barges crack fell again today, sitting at historically low levels. For perspective, the front month average of this crack from 2019 to now is -\$14.51/bbl; Its currently printing -\$34.65/bbl. There's no clear answer for this collapse, however one possibility is that the Chinese production quotas are resulting in higher fuel exports to the West, thus increasing supply in this region and so weakening the high sulphur euro crack.

380cst Sing spreads came off today, with the first real movement that we've seen for weeks. Nov22/Dec22, Dec22/Jan23 and Jan23/Feb23 spreads dropped 50 cents to -\$4.00/mt, -\$5.00/mt and -\$5.25/mt, respectively. Mar23/Apr23 dropped by \$1.00/mt


