
Oil and Energy Market News


Brent crude futures are down around \$1 from Friday still in limbo with regards to China's demand levels. Recent data for September showed that fuel demand remained lackluster in the world's biggest crude importer, weighed down by strict Covid-19 policies.

There have been estimates that Russia could continue to ship 80-90% of its oil outside the price cap regime via its own tankers and insurance services.

The strikes which struck the French refining sector over the last several weeks have resulted in less marine fuel production in Northwest Europe, which slightly eased the oversupply.


