



Iron ore retreated to below \$95 on Tuesday in response to the news of production curbs in Hebei. As the Party Congress will be held in Beijing on 16 Oct, steel mills in the neighbouring regions are required to limit output to ensure blue skies for the showcase events. In terms of iron ore demand, sales in both seaborne and portside markets were reported to be slow with falling prices.
