

Market Commentary / Recent Trades

Iron ore futures plunged today following the pessimistic views of steel demand and Chinese economic growth. The prompt contracts took a bigger hit during the morning session, with the Nov contract falling from \$87 to \$82.20, Dec from \$84.35 to \$80.25 and Jan gave up over \$5 to move to \$79.20. The losses also extended to the far out contracts, Q1 fell straight from \$81.50 to \$78.85, and Cal 24 was down \$2 to \$71.25.


