## FUTURES MARKET COMMENTARY

**NOLA:** NOLA continues to be quiet on Urea. We saw phys offers at \$520 today on NOV after it traded there yesterday. In the futures market there was one spread trade today (FEB vs MAR @ -20, 560 & 580 respectively). Did some digging this afternoon and saw a couple interesting points:

1) The open interest for NOLA UREA futures is 169k for comparison it was 311k last year on the same day.

2) NOLA UREA has fallen off the commitment of traders list in March of this year.. meaning there are less than 20 active participants in the cleared market since March of this year.

**INTL:** Another slower day in the international market, as the physical market remained slow. AG traded early on at \$535 for Dec and then \$580 for Nov. We then saw interest return to the market on Dec Egypt, as it traded at \$545. We had some interest on both sides on the follow.
