





A very very quiet afternoon on iron ore with the only trades of not being NOV/DEC finally trading at \$0.75 in 50kt and Q1/Q2 trading \$1.85 in 5kt twice. Flat price was, well, largely flat throughout the session at \$86.15 before making modest gains to \$86.50 heading into close.
