





A slight pick up in liquidity in the afternoon as CAL23 traded \$83.60 in 1kt, though outright front contracts remained in the forefront as NOV traded \$88.40 in 110kt and DEC traded \$88.15 in 80kt. Aside from those, clip sizes were largely on the smaller side throughout the session.
