



Iron ore saw reasonable trading in the afternoon, with more interest spread further back along the curve. DEC/JAN remained stuck for the majority of the session 0.85/0.90 but did eventually get sold at 0.85 in 50kt. Q1 traded several times in smalls, and DEC/Q3 traded 5.15 in 15/5kt/m, having printed the same size and level during the London morning.
