



Main axe of the afternoon was NOV/JAN which saw trading between -0.45 and -1.40 in clips as large as 100kt towards the end of the session. NOV/DEC also enjoyed decent liquidity trading -1.75 and -1.50 in 70kt and 35kt apiece. Limited interest at the back with Q2 the only real trade outside the monthly's trading in 7kt/m. On the outrights the majority of interest was firmly concentrated on JAN, having run into some selling towards the end of the break.
