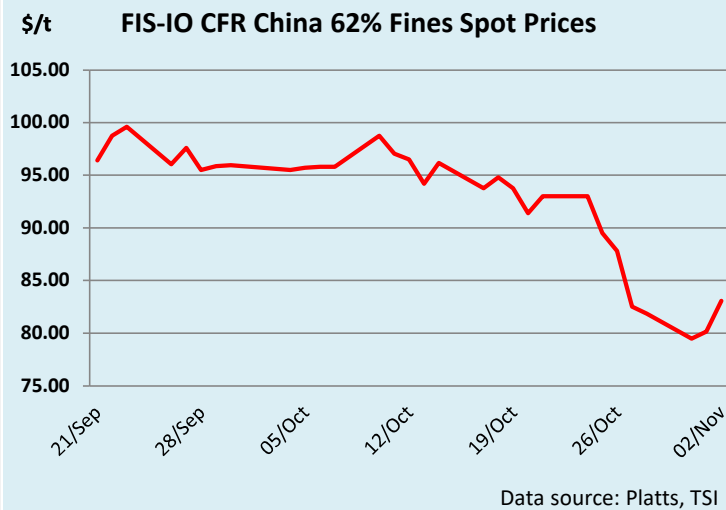

Market Commentary / Recent Trades

Iron ore continued its gains on Wednesday as an unconfirmed speculation that Beijing will start considering how to ease stringent Covid Zero rules. 5 out of 25 blast furnace of Tangshan started maintenance, or a decrease of 21,600 pig iron production. However some mills actively cut production concerning the low margin and weak downstream demand. prices of imported iron ore for both port inventories and seaborne cargoes rose again on November 2, while trading activity cooled after the prior day's short-lived recovery.

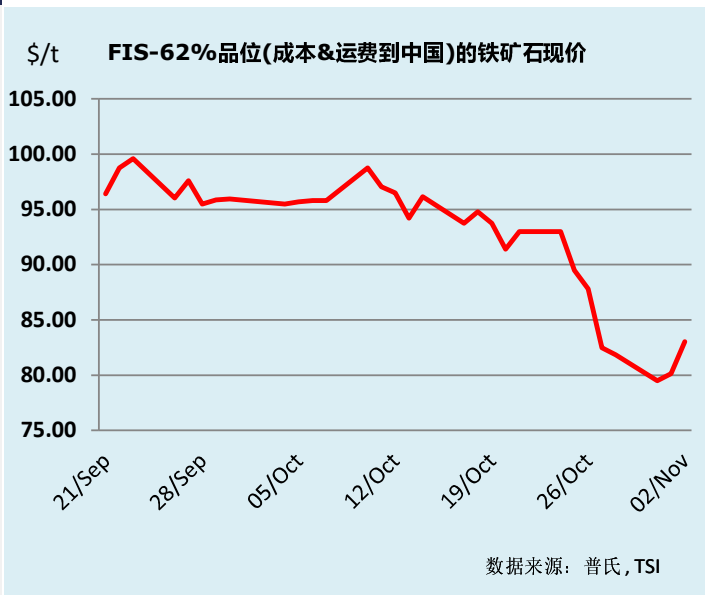

I 周三铁矿石价格继续上涨，市场情绪转好，此前有未经证实的猜测传出，即北京将开始考虑如何放松严格的新冠肺炎零疫情规定。唐山25座高炉中有5座开始检修，生铁产量或减少2.16万。由于利润率低和下游需求疲软，一些钢厂积极减产。11月2日，港口库存和海运货物的进口铁矿石价格再次上涨，而交易活动在前一天短暂反弹后有所降温。
