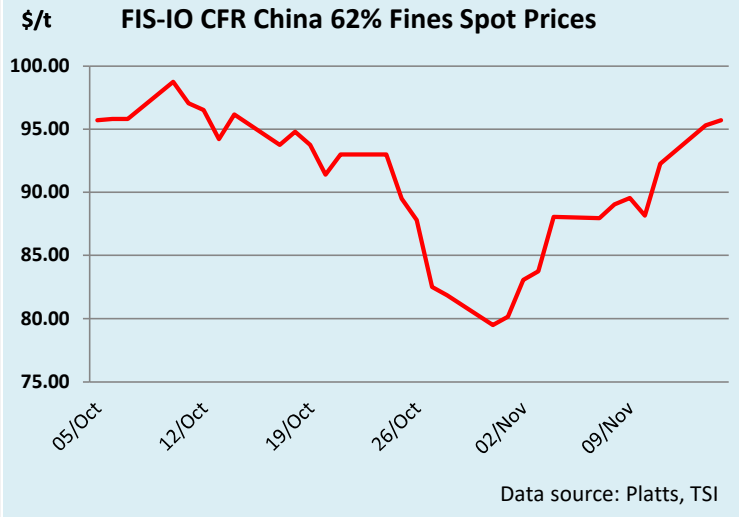

## Market Commentary / Recent Trades

Iron ore futures climbed for a third day following the boosted demand outlook as China reported nearly 80 million tonnes of national steel production for October, an 11% increase over the same period last year. Meanwhile, steel prices rose as Beijing adjusted its rules for dealing with Covid-19 and rolled out support for the property market. Iron ore has rebounded this month after hitting its lowest level last month since early 2019.

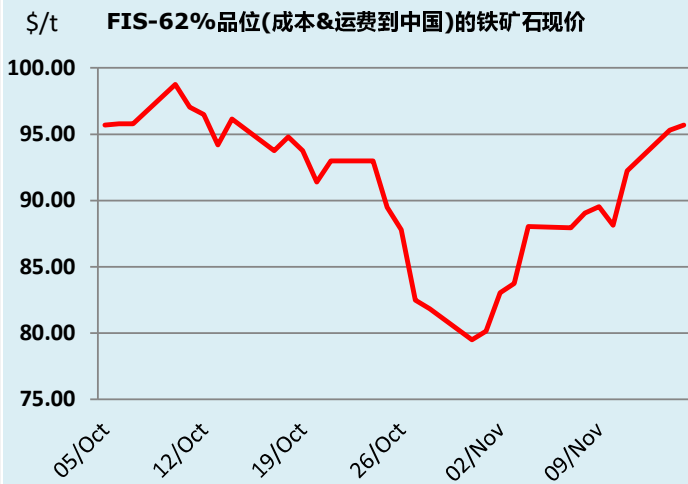

铁矿石期货价格连续第三天上涨，此前中国公布10月份全国钢铁产量接近8,000万吨，较去年同期增长11%，需求前景得到提振。与此同时，由于中国政府调整了应对新冠肺炎的政策，并推出了对房地产市场的支持，钢铁价格上涨，铁矿石价格在10月触及2019年初以来的最低水平后，本月出现反弹。
