Market Commentary / Recent Trades

Iron ore continued to make further gains this week on the optimism of recovering demand, after the Chinese government easing some covid restrictions and pledging further support to the property market. In terms of output in early Nov, crude steek output still showed in decline according to the latest report from China Iron and Steel Association (CISA). Futures contracts also edged up today along amid better prices heard in seaborne and portside markets, with Nov and Dec firming up to \$93.30 and \$96.10 respectively, Jan opened at \$93.70 before moving towards \$96.
