

#### **Market Commentary / Recent Trades**

The iron ore market had a bullish run today, with prices surpassing the \$100 mark on the back of fundraising support. In addition, yesterday, the China Securities Regulatory Commission (CSRC) said they would reopen and broaden refinancing channels to property companies, and the move lifted market sentiment. As a result, China and Hong Kong property complex indices surged over 8%. In the futures market, prompt contracts moved up over a dollar.
