### <u>NOLA</u>

The NOLA UREA market continues to make its' way back up today with phys and futures moving higher, but most activity seen on phys. For January barges we saw them trade in a \$500-\$505 range today at the time this was written and saw FEB barges change hands at \$510. On paper we saw March trade at \$545 (OTC) – this is up \$10 from last done. No cleared CME futures trades for NOLA at the time this was written.

#### <u>INTL</u>

AG Jan'23 continued to attract interest, as it traded early on at \$490. And on the follow the frame was around last done. Dec'22 Egypt was framed around 540 / 570, around where the first week index printed. The market seemed a little quiet today, and traders were shy to show firm numbers.
