Market Commentary / Recent Trades

Iron ore prices continued to fall as China's sudden abandonment of its zero covid policy sparked fear of economic disruption. Market participants are now trying to gauge the impact on the economy and the prospects for a recovery in the struggling real estate sector. Prices for seaborne cargoes of imported iron ore eased slightly today, while those for port inventories stayed the same. Meanwhile, trading activity in both markets picked up.
