As trainee broker and analyst Lobsy Li informed us when we're drinking tea in the tea room yesterday at 7pm London time, we were stuck \$6600 v 6700 Feb cape, tonight at 3pm we are stuck \$6600 v 6700 Feb cape- which pretty much sums up the market right now. Physical is non-existent, the front isn't moving and the Q3,Q4 and Cal 24 are bullet proof and refusing to go down- which could have been said for the last two days and looking likely to be said for the next couple of days too. The majority of the volume is going through on Q3,Q4 and Cal 24 itself but in all honesty it feels while Q2 saw good volume changing hands inside \$14100like we need the return of the far east and some physical action to 14200, while further out rates held with good underlying get some interesting chat about the market going. The index is at support as the carry continues to steepen. \$5684, probably going to \$4500-4750 level before we see a turn and a positive index. Until then, we all sit about and see if the trend of a weak front and a bullet proof back end breaks.

**Capesize Commentary** 

Pmx paper slipped in early trading before settling into a steady range through most of the remainder of the day. The index bough with it little surprise which made for limited action up until the close where buyer started to test the upper end of the day's range but were met with sharp resistance and ultimately drifted lower. Feb saw good size trading around \$9500 and similarly march round \$12500
