#### **Panamax Commentary**

A largely range bound day on capes with early selling pressure running into some support at \$5500-5600 on Feb and \$8600 on march. The size selling was absorbed at these good support across the curve, prompt periods nudging up levels before gradually ticking up towards closing levels by the end of the day. Q3 was sold early on at \$19800 and traded towards the end of the day at \$19750 - indicative of the range we traded in. Today however perhaps marked a shift on the front of the curve where the size selling interest was unable to drive the market lower, indicating potentially a localised floor on the prompt months. The index came in lower -118 to \$4433. Most of the action was in the morning session with activity limited later on - perhaps to be expected at the end of the week that included Chinese New Year. Have a good weekend!

**Capesize Commentary** 

Active end to the week for the pmx with pockets of activity and a steady increase in rates. Generally we witnessed \$300-\$400 as Feb traded at \$10000 and March at \$13000. Q34 gained more traction printing up to \$14650 in size which in turn prompted buying of Q234 strip trading in good size between \$14500-\$14550. Further out more rangebound activity with cal24 trading \$13500-13600 and cal25 \$13000-13050. Have a good weekend.
