


London Iron Ore Market Report



The T+1 saw flat prices drop from the buoyant levels seen over the London morning amid size trading on the outrights and little love shown on the spreads. Trading in clips of up to 200kt were seen trading out till march, amid steady clips on JAN and FEB going through.
