



Iron ore prices well and truly collapsed in the London afternoon. Having reached highs of 126.30 earlier in the day, front month futures closed out just over \$4.5 lower at 121.75. The afternoon was dominated by outrights selling pressure across the front, though the afternoon kicked off with some size interest on FEB/APR going through at 1.80 in 100KT, pushing spreads in a touch. Limited interest was seen at the back throughout the afternoon.
