




## 30 January 2023

A slow start to the week after the holidays with very little size trading going through, particularly on the spreads. FEB/MAR saw a bit of liquidity at \$0.60, again in smalls and FEB/APR saw interest in several clips at \$1.35 in 25KT a piece, having traded in a similar pattern last week. Down the curve Q1'24 was sold aggressively over the afternoon and Q2'23 saw light trading. Jan/Feb also seen trading at -\$5.4 and -\$5.5 in 10kt apiece despite only one pricing day remaining on Jan.
