


## **London Iron Ore Market Report**



March fell from \$130.3 to \$129.65 during London afternoon, then recovered to \$130.40 before close. Apr moved from \$129.60 to \$129, while Q2 and Q3 trading flat at \$128.25 and \$125.50 respectively. Spread wise, good size saw on Mar/Apr at 0.65, Q3/Q4 at 2.55.
