Market Commentary / Recent Trades

Iron ore rebounded a touch, with futures gaining nearly \$2
on Friday. However, the lower-than-expected steel demand
and doubt about the pace of the Chinese economic recovery
are wiping off the previous week's gains in the iron ore. On
top of that, supply from Australia is expected to increase this
year after the China-Australia talk. On the industrial side, the
blast furnace utilisation rate among 247 Chinese steel mills
was stable at 84.32% for the week ending 2 Feb. The
average blast furnace operation rate ticked up 0.72% w-o-w
to 77.41%, as stated in Mysteel's industry survey, indicating
mills resumed operations but at a slow pace during the New
Year holiday period. Meanwhile, imported iron ore
inventories at 54 Chinese steel mills climbed to a five-month
high of 139.1 million tons, up 1.4% or 1.9 million tons per

市场评论/近期交易 周五铁矿石期货价格小幅反弹,上涨近2美元。低于预期的钢铁 需求和对中国经济复苏速度的质疑,抹去了铁矿石上周的涨幅 。除此之外,在中澳会谈后,澳大利亚的供应预计今年将增加 。在工业方面,截至2月2日当周,247家中国钢厂的高炉利用 率稳定在84.32%,据我的钢铁网行业调查显示,平均高炉开 工率同比上升0.72%至77.41%,表明钢厂在春节假期期间恢 复了生产,但速度缓慢。与此同时,中国54家钢厂的进口铁矿 石库存攀升至1.391亿吨的五个月高点,较上周增加1.4%或1 90万吨。
