Market Commentary / Recent Trades

Iron ore edged up on Wednesday on the back of stable buying interests and increasing trading volume in the seaborne market. Lower than expected steel demand dragged prices down for the past week, but some rebound appeared during the Asian trading session, saw Feb moving up from sub \$120 to \$121, and then \$121.75 into the London morning; Apr and May also ticked up to \$120.35 and \$119.35, respectively.
