Market Commentary / Recent Trades

With Asian stock index fell to one month low ahead of US CPI release, iron ore headed lower today on the back of stronger US yields. On the other hand, steel demand showed an uplift in early Feb. According to a Mysteel industry survey, the daily crude steel production among 247 Chinese BF and 71 EAF steel mills increased 2.9% to 2.69 million tonnes per day during 1-10 Feb.
