Market Commentary / Recent Trades

Iron ore futures continued gains on Tuesday due to a better demand outlook. As the Chinese government works to stimulate the economy after ending its strict zero-COVID policy, steel mills started restocking; construction activities are expected to pick up from the second quarter. On Monday, Beijing announced another pilot scheme to boost private investment in real estate. Prices of imported iron ore for both port inventories and seaborne cargoes continued climbing higher.


