

Market Commentary / Recent Trades

Growth targets of only 5% from China sent iron ore futures tumbling yesterday on the Asian open. The exaggerated drop (USD 4.50) in the front end futures found much needed buying support just above USD 121.00 level, partly this will have been a technical play as price opened on the 50 period EMA. However, optimism that steel demand will picking up ahead of the peak construction season seems to have been the market driver today. One note of caution, 3 and 5-year seasonality values don't tent to turn higher until around the 23/03, suggesting that if this is the case then they may have come in a little early.

市场评论 / 近期交易

中国仅5%的经济增长目标导致铁矿石期货昨天在亚洲开盘时暴跌。即期合约的夸张下跌(4.50美元)在121美元水平上方找到急需的买盘支撑,部分原因是技术面开盘价位于50周期均线。然而,对钢铁需求将在建筑旺季之前回升的乐观情绪似乎一直是今天的市场驱动力。值得注意的是,3年和5年季节性值在3月23日左右才会转高,这表明季节高点可能来得有点早。
