

#### **Market Commentary / Recent Trades**

Iron ore halted its five-day rebound and traded lower on Wednesday after hearing about China's plans to cut steel output for low emission target. The potential production curb added some pressure on the raw material prices today; iron ore front months fell over \$1, with Apr moving from \$132.7 to \$131.7 and \$131.55, Q2 from \$131.85 to \$130.5. Large size traded in Mar/Apr at \$1 and \$1.1. In addition, in the first two months of this year, China's crude steel output rose 5.6% YoY to 168.7 million tonnes, and pig iron output jumped 7.3% YoY to 144.26 million tonnes, data released by the National Bureau of Statistics (NBS) showed.

#### 市场评论 / 近期交易

在中国计划削减钢铁产量以实现低排放目标后,铁矿石周三停止了连续五天的上涨。限产消息使得今日原材料价格承压;铁矿石期货即期合约跌幅超过1美元,4月从132.7美元跌至131.7美元,随后至131.55美元,Q2从131.85美元跌至131.85美元,3月和4月价差交易于1美元和1.1美元并有不错交易量。此外,国家统计局公布的数据显示,今年1至2月,中国粗钢产量同比增长5.6%,至1.687亿吨,生铁产量同比增长7.3%,至1.426亿吨。
