

Iron ore continued to rise amid steady seaborne buying activity and returned market optimism about steel demand in the construction season. The futures market also saw further gains during today's day session, seeing Apr steadied at \$122; May moved up from sub \$121 to \$122.2-\$122.5 at the latter part of the session; Jun traded at \$119.9 and then up to \$121.45 before the close.
