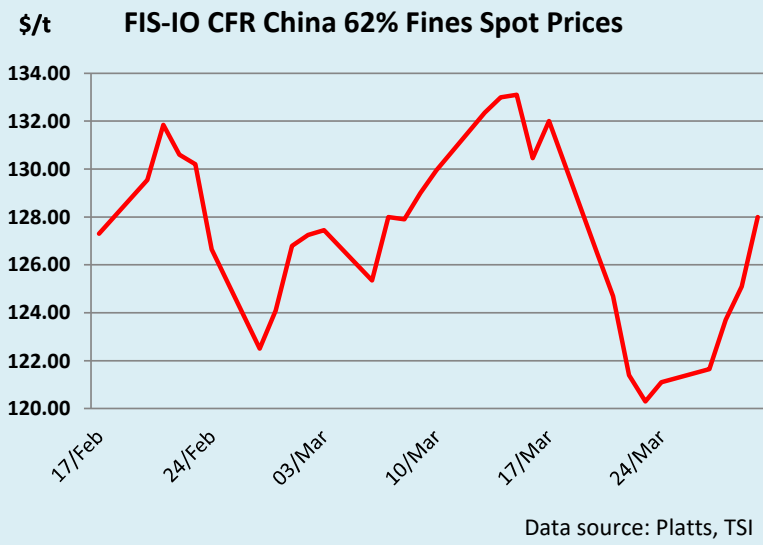

Market Commentary / Recent Trades

Iron ore firmed up on Thursday with market expectations of accelerated restocking from mills. According to a Mysteel survey of over 64 Chinese steel mills, the daily consumption of imported iron ore sintering fines rose 3.2% or 17,700 tonnes/day from last week to 566,900 tonnes per day over 23-29 March. As a result, mills' stockpiles have been easing over the period. In addition, news of Brazil and China signed deals for iron ore trades in their currencies instead of the dollar. However, the impact on the seaborne flows is likely to be minimal. In the futures market, Apr increased from \$124 to \$126.7, May moved up nearly \$3 and traded at \$125.5, and Jun was up from sub \$122 to \$123.05 at the close. Gains also extended to the deferred contracts, with Q4 rising from \$115.4 to \$117.7. Spread-wise, decent volumes saw in May/Aug at \$3.5 and Q3/Q4 at \$3.1.

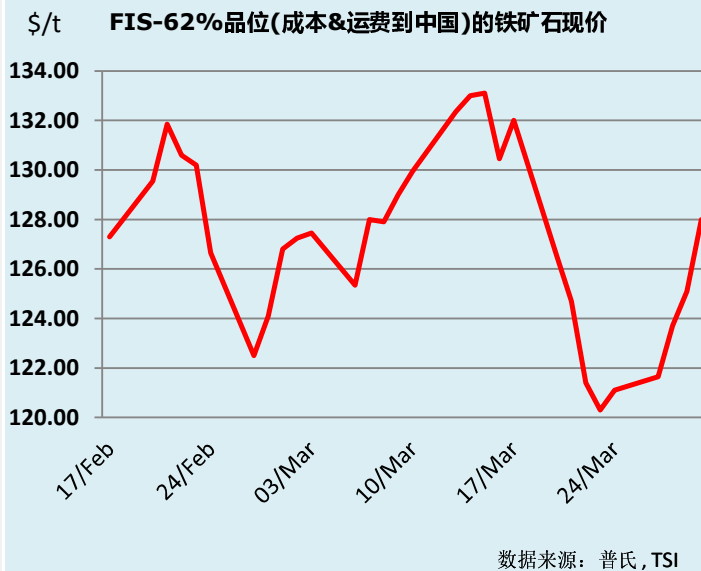

市场评论 / 近期交易

铁矿石价格周四上涨，市场预期钢厂将加快补充库存。据我的钢铁网对中国64家钢厂的调查，3月23日至29日，进口铁矿石烧结粉的日消耗量比上周增加了3.2%，即1.77万吨/天，达到56.69万吨/天。钢厂的库存在这段时间一直在减少。此外有消息称，巴西和中国签署了以本币而非美元进行铁矿石交易的协议，但这对海运流量的影响可能微乎其微。在期货市场，4月从124美元小幅上涨至126.7美元，5月上涨近3美元，交易于125.5美元，6月从低于122美元上涨至123.05美元。远期Q4也出现上涨，从115.4美元升至117.7美元。价差方面，5/8月交易于3.5美元，Q3/Q4为3.1美元。
