
Oil and Energy Market News


Oil prices have stalled as it seems that market participants have finished covering their short positions last week, after OPEC+ announced surprise output cuts at the start of the month. The shock caused funds and institutions to lift 36 million barrels in the top 6 oil futures and options over the 7 days ending April 11.

Brent crude futures settled on Friday at \$86.31/bbl, where they traded fairly flat for most of the day, before coming off into the afternoon to trade the lows of the day so far at the time of writing.

VLSFO spreads were illiquid and finish flat on the day, whilst we saw the HSFO spreads for both Euro and Sing contracts pushing marginally.

Rotterdam 3.5% barges crack is printing almost one dollar stronger as we approach UK market close – at -\$13.66/mt for May23. VLSFO Euro and Sing cracks are stronger on the day by 20 cents and 40 cents, respectively.


