


## **London Iron Ore Market Report**



A quieter session seen in the afternoon than the morning with less emphasis seen on the spreads, and more concentrated at the front of the curve. IO closed up on the day amid stimulus sentiment closing out 118.20 vs yesterday's 116.85. Spreads were pushed out earlier on by a strong CAL24/25 8.75 pay.
