


London Iron Ore Market Report



Spreads were the main ticket of the afternoon, coming in even further over the T+1 to round out a volatile week for Iron Ore. MAY/JUN tightened to 2.25 trading in 180KT during the session having traded 2.30 over the break. Outright liquidity was lacking though trading was seen at Q3 in small clips. Having opened the week 114.90, Iron ore closes out just under \$10 down on the week.
