#### **Market Commentary / Recent Trades**

Iron ore climbed on Tuesday after one of the largest iron ports Port Hedland declaring cyclone alerts for this week. Apart from the concerns that iron ore shipment could be halted leads to tight supply, the decline of Chinese steel stockpiles stirred up the market optimism over short term demand. In the futures market, Apr moved up from the opening \$119.60 to \$121.3 where most of the volumes changed hands, then up again to \$121.6 before closing; May as the active contract jumped from sub \$117 all the way up to \$119.75 and \$119.85. Likewise, Jun traded from 115.6 to 118.2. High interests also saw on spreads with Apr/Jun trading at \$3.4 in large size, May/Jun trading at \$1.65 and \$1.7, Jun/Aug at \$2.80, Jul/Sept at \$2.75.

#### 市场评论 / 近期交易

在最大的铁矿出口港口黑德兰港发出飓风警报后,铁矿石价格周二攀升。除了担心恶劣天气导致铁矿石出货可能会暂定和供应紧张外,中国钢材库存的下降也激发了市场对短期需求的乐观情绪。今日新交所期货市场,4月合约从开盘价119.60美元上涨至121.3美元,大部分成交量集中于此价位,收盘前再次上涨至121.6美元;主力5月份合约从117美元下方一路上涨至119.75美元和119.85美元。相似,6月从115.6美元交易到118.2美元。价差交易兴趣也很高,4月/6月有大笔交易量在3.4美元,5月/6月交易价为1.65美元和1.7美元,6月/8月价差为2.80美元,7月/9月交易价为2.75美元。
