Market Commentary / Recent Trades

Iron ore declined further after the Chinese authority released plan to cap the annual steel output by the end of this month. Moreover, market sources reported that iron ore was sold lower in both the seaborne and portside markets today despite improving trading activity. During the Asian day session, prompt contracts dipped over \$1 before bouncing back to just below the opening level at the latter part of the session. May traded from high \$116 to sub \$115 where most of volumes changed hands, then recovering to \$116.4. Jun traded at a tight \$113.8-114.7 range; Jul moved from \$112.95 to \$112 but lifting to \$113.20 at the close. Less action reported on spreads today, decent volumes on May/Aug at 3.65 then widened to 3.95 at the close, May/July traded couple of times at \$3.2.

在中国当局计划于本月底发布今年钢铁限产计划后,铁矿石价格进一步下跌。此外,据市场消息报道今天海运和港口市场的铁矿石价格均有所下降,但交易活动有所改善。在亚洲时段,即期合约下跌超过1美元,但后半段反弹趋近开盘水平。5月合约价格从116美元跌至115下方,且在此价位有良好交易量,收盘前5月回升至116.4美元。6月交易于113.8至114.7美元窄幅区间;7月先从112.95美元跌至112美元,但在收盘时升至113.20美元。价差行动相对较少,5月/8月有不错的交易量在3.65,收盘时扩大至3.95,5月/7月有数笔交易在3.2美元
