


Oil and Energy Market News

Predictions for the direction of oil prices have become oddly polarised, with economists turning more bullish despite a currently bearish market. The forecasts of energy economists are not parallel with the actions of speculative traders. Despite banking fears and the debt ceiling discussion, it's hard to find a proper justification for the growing bearishness in the oil markets.

This afternoon, Brent crude Jul23 futures eased back from the highs of the day with prices falling back from near the technical resistance levels at the 10 May high of 77.60\$/bbl.

Euro 0.5% crack was very illiquid today, not trading at all until 1615 GMT and printing 10 cents stronger than a \$1.81/bbl settlement as we approach the close. Sing 0.5% crack is marginally weaker at \$9.25/bbl.


