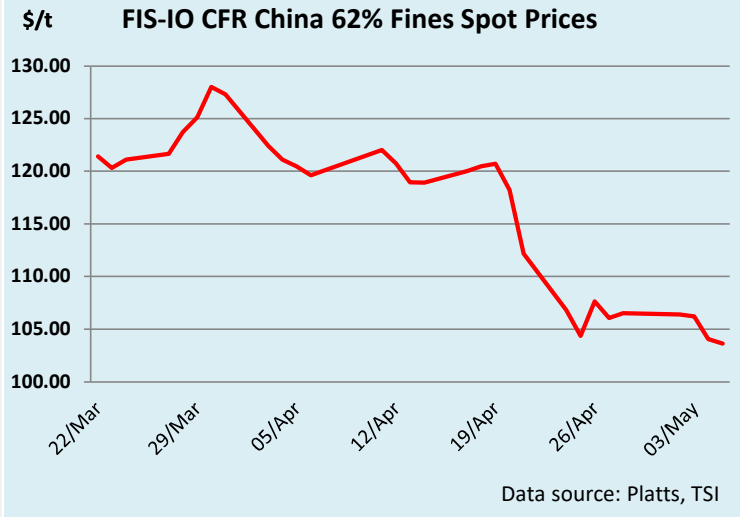

Market Commentary / Recent Trades

A small recovery on iron ore as futures gained up to \$98.75 at the time of writing. At the back CAL24/25 traded a touch lower at \$7.10 in smalls with much of the size interest at the front trading several times around 116 in some tricky sizes (115.9 and 1116 KT several times).

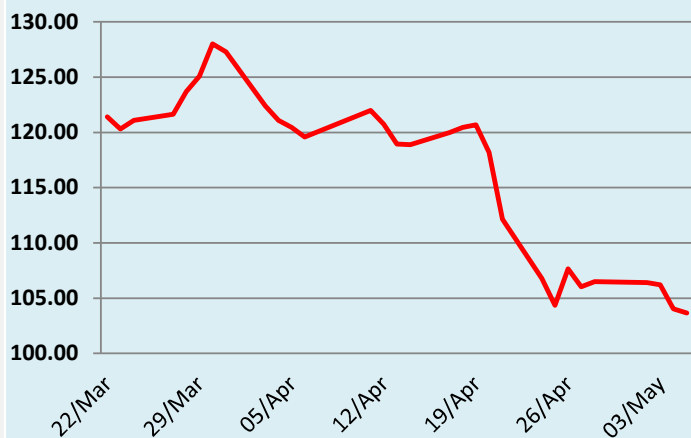
